Whereas, among other areas, Agenda 21 promotes changing consumption patterns, achieving significant changes in the consumption patterns of industries, governments, households and individuals (2); promoting human settlement development, which promotes moving populations away from rural areas and into cities (3), and many other areas that adversely affects our sovereignty as a nation, and has no business in our City/County government, and

Whereas, the United Nations and ICLEI openly support and attempts to enforce unconstitutional, anti-American policies regarding the ownership of land, TO WIT:

1. Land, because of its unique nature and the crucial role it plays in human settlements, cannot be treated as an ordinary asset, controlled by individuals and subject to the pressures and inefficiencies of the market. Private land ownership is also a principal instrument of accumulation and concentration of wealth and therefore contributes to social injustice; if unchecked, it may become a major obstacle in the planning and implementation of development schemes. Social justice, urban renewal and development, the provision of decent dwellings-and healthy conditions for the people can only be achieved if land is used in the interests of society as a whole.

2. Instead, the pattern of land use should be determined by the long-term interests of the community, especially since decisions on location of activities and therefore of specific land uses have a long-lasting effect on the pattern and structure of human settlements. Land is also a primary element of the natural and man-made environment and a crucial link in an often delicate balance. Public control of land use is therefore indispensable to its protection as an asset and the achievement of the long-term objectives of human settlement policies and strategies.

Whereas, corrupt legislatures and bureaucrats, at all levels, in violation of their oath of office to preserve, protect and defend the U. S. Constitution, have passed and are continuing to pass, voluminous, unreadable, incoherent acts, ordinances, regulations, restrictions, edicts, laws and ratify treaties that are in direct violation of the strict and literal interpretation of our federal or state constitutions, pursuant to the intent of the framers of those constitutions, and

Whereas, the U. S. and state supreme courts have failed in their duty to literally interpret our Constitutions as the supreme law of the land and have inserted, in some cases, radical political, environmental, or socialist biases into their decisions, thereby rendering those decisions in direct conflict with the literal interpretation of the U. S. Constitution, and

Whereas, the net result of these acts by government, at all levels, is that all American citizens have lost most if not all of their freedoms, their liberty, their property rights and American sovereignty, to the corrupt, unconscionable and unconstitutional violations of the supreme law of the land, at the hands of federal, state and local politicians, lawmakers and bureaucrats, and

Whereas, all American political officer holders, being the people's elected representatives, are required by law to represent the interests of the people within their jurisdiction and are further required to preserve, protect and defend the constitution of the United States and the constitution of their state. They are not required or authorized by the people whom they serve, to comply with any other law but American law.

Now therefore, the signatories to this petition demand that the commissioners/council withdraw immediately from ICLEI and repeal and resci documents and actions that are in compliance with ICLEI's directives or "suggestio further money to ICLEI and/or the United Nations, and	•

At the meeting, have a spokesperson read the petition language into the public record and then submit the petition, along with the signatures, to the City/County clerk that is present at the meeting. After reading the petition, make a formal request to the City/County to take up the subject of the petition at a "meeting of the whole" within no less than 30 days. They may not do as you requested, but they will have been put on notice that you are serious, in front of those citizens attending the meeting. Make sure that you file copies of the petition with the local news media in advance and state your intentions of when it will be presented to the City/County.
